There were no members of the public present.

The Chair welcomed those present and thanked everyone for attending the second online meeting held by Lound Parish Council.

1. Welcome & Apologies - apologies from Peter Larcombe.

2. Declaration of Interest - Declaration of any pecuniary or other interest with regards to items on the agenda. Judith Hobbs declared an interest in the maintenance project for Blacksmiths Loke.


3. Minutes of The Last Meeting and Matters Arising – The minutes of the Parish Council Meeting held 11th May 2020 were proposed and seconded. These will be signed by the Chair and the Clerk at the next opportunity.

4. Updates –

- **Neighbourhood Planning Update** – The draft plan has been submitted to ESC. However, the inspection has been deferred to 20/21.
- **Progress with Blacksmiths Loke** – This work has now commenced and is progressing well. It is expected that it will be completed on Thursday 6th August. The two grants of £1000 each has been received and some of the contributions from residents have been received with the remainder expected shortly.

5. Correspondence – There were three items of correspondence:

- Email from SALC regarding a consultation on a draft code of conduct for members. Councillors voted to respond individually.
- Email from ‘Quiet Lanes Suffolk’ regarding a scheme for single lane roads in the area. The council voted not to take any action on this at present.
- Email from ESC asking for information and nominations for individuals/organisations that have provided support during the Covid-19 lockdown. It was decided that Lound PC will forward information about the scheme in Lound. The clerk will forward to the appropriate person.

- The Litter pick has been scheduled for 26th September weather permitting and 17th October as a back up date. As it is not possible to borrow the tools at the moment due to Covid-19 it may be possible to purchase these and claim a grant from ESC. Miles will gain a quote.

7. Annual Internal Audit – The internal audit procedure was reviewed and agreed as adequate. The Annual Audit Report was inspected and noted.

8. External Audit (AGAR) –

- a) The Annual Governance Statement was approved by the Council.
- b) The Accounting Statements were approved by the Council.
- c) The Certificate of Exemption was approved by the Council.

11. Dates of Next Meetings – The clerk will make enquiries regarding availability at The Village Hall for the next few meetings.



12. Councillors Forum –
